### Election of Means of Receipt and Language of Corporate Communications

Pursuant to Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Articles of Association of Razer Inc. (the “Company”), the Company will make available the following options for you to elect the means of receipt and the language of future corporate communications (“Corporate Communications”) of the Company, which means all documents issued or to be issued by the Company for the information or action of any holders of its securities, including but not limited to (a) directors’ reports, its annual accounts together with a copy of the auditors’ reports and, where applicable, summary financial reports; (b) interim reports and, where applicable, summary interim reports; (c) notices of meeting; (d) listing documents; (e) circulars; and (f) proxy forms, in the following manners:

- (1) to read future Corporate Communications published on the Company’s website at [www.razerzone.com](http://www.razerzone.com) (“Website Version”) instead of receiving printed copies, and to receive a written notification by post of the publication of the Corporate Communications on the website of the Company; or
- (2) to receive the printed English version of all future Corporate Communications only; or
- (3) to receive the printed Chinese version of all future Corporate Communications only; or
- (4) to receive both the printed English and Chinese versions of all future Corporate Communications.

In support of environmental protection and for the purpose of saving costs and increasing efficiency, the Company recommends you to elect the Website Version. To make your election, please mark (X) in the appropriate box on the enclosed reply form and sign and return it by post or hand delivery to the Company c/o its share registrar of Hong Kong (the “Hong Kong Share Registrar”), Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong. If you post your reply form in Hong Kong, you may use the mailing label in the reply form and need not affix a stamp when returning your reply form. Please affix appropriate postage stamp when posting outside Hong Kong.

**If the Company does not receive the enclosed reply form duly completed and signed by you or a response indicating the objection from you by April 9, 2018 and until you inform the Company c/o the Hong Kong Share Registrar by reasonable prior notice in writing or by email to [razer.ecom@computershare.com.hk](mailto:razer.ecom@computershare.com.hk), you will be deemed to have agreed to receiving the Website Version instead of receiving printed copies of all future Corporate Communications, and a written notification of the publication of the Corporate Communications on the Company’s website will be sent to you in the future.**

You have the right at any time by reasonable notice in writing to the Company c/o the Hong Kong Share Registrar or by email to [razer.ecom@computershare.com.hk](mailto:razer.ecom@computershare.com.hk) to elect (i) to receive future Corporate Communications in printed form instead of the Website Version (or the Website Version instead of in printed form) and/or (ii) to change the language in which you receive Corporate Communications in printed form. If you have elected (or are deemed to have agreed) to receive the Website Version of Corporate Communications but for any reason have difficulty in obtaining access to the Website Version of a Corporate Communication, the Company will promptly upon your request send the Corporate Communication to you in printed form free of charge.
